**CONSULTATION : SEGGIMIRE LANE, LITTLEBECK, WHITBY. PROHIBITION OF MOTOR VEHICLES EXCEPT SOLO MOTOR CYCLES.**

The County Council, as Highway Authority for the area, is proposing to amend the existing traffic regulation orders on Seggimire Lane to prohibit motor vehicles except solo motor cycles as shown on the attached plan.

The Council is required to consult those directly affected by the proposal and the purpose of this letter is to provide you with details of the scheme and allow you the opportunity to express your views.

Attached is a plan showing the proposed location of the scheme and a simple questionnaire for you to signify your views regarding the proposal. **Please return questionnaires by 12th February 2015.**

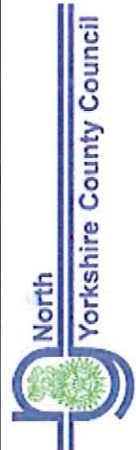
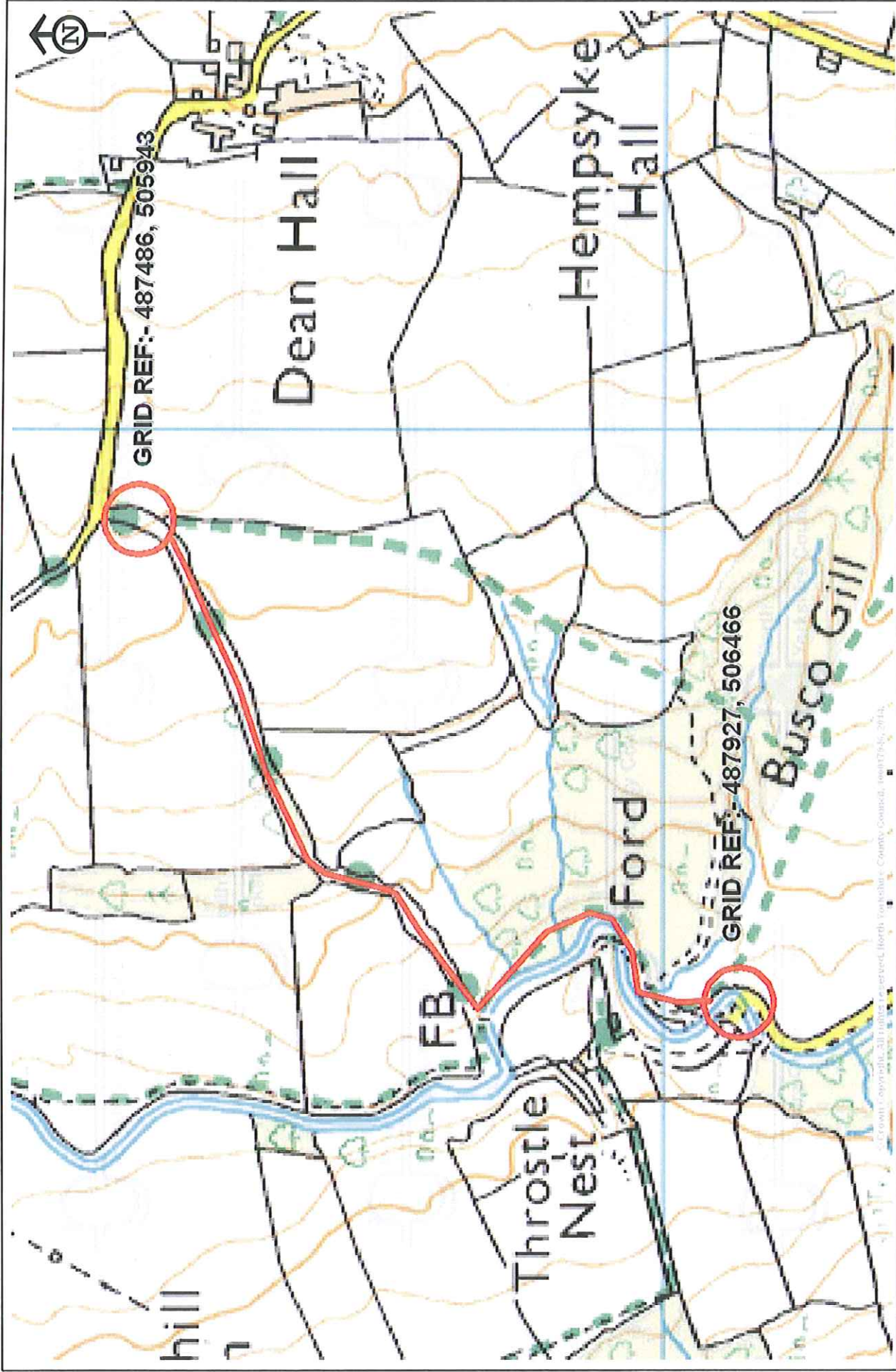
It is also the duty of the Council to legally advertise this proposal which will be done in parallel with the consultation exercise. The legal process includes site notices and adverts in the local press detailing the specifics of the Traffic Regulation Order amendment.

If there are no objections to the proposals, it is anticipated that the scheme would be implemented within six months from the end of the consultation period. However, if objections are raised which are not resolved or withdrawn, it will be necessary to report them to a meeting of the County Council's Executive Members overseeing the responsibilities of Business and Environmental Services (BES) and Corporate Director, BES, David Bowe, to decide whether the objections should be upheld or overruled.

The date and venue of any meeting together with conditions regarding public access will be advised, if applicable. I trust this is satisfactory and look forward to receiving your comments.
